Call for Papers

17th Workshop on Corporate Governance and Investment

Istanbul

September 30 - October 1, 2016

Koc University, Sabanci University - CGFT, Corporate Governance Association of Turkey

The 17th Workshop on Corporate Governance and Investment will take place at the Campus of Sabanci University, on Friday September 30 and Saturday October 1, 2016.

The workshop is an initiative of a group of researchers to meet regularly in a workshop format, where participants from different countries present papers in an advanced stage. The first meeting of the group took place with seven participants in Cambridge (CBR Judge Business School - Cambridge University) in 1998 and was initiated by Prof. Dennis Mueller (University of Vienna). The workshop in Istanbul will have been the 17th since this first meeting.

Other meetings of the group have taken place in Aarhus (Aarhus University 1999), Berlin (DIW 2000), Cambridge (CBR-Judge, Cambridge University 2001), Vienna (University of Vienna 2001), Palma de Mallorca (University of the Balearic Islands 2005), Jönköping (JIBS - Jönköping International Business School 2006), Cambridge (CBR-Judge Business School - Cambridge University 2007), Istanbul (Sabanci University 2008), Copenhagen (CBS 2009), Barcelona (Universitat Autònoma de Barcelona 2010), Leipzig (HHL 2011), Cardiff (Cardiff Business School 2012), United Arab Emirates (American University - Sharjah School of Business Administration 2013), Oslo (Norwegian Business School 2014), and Manchester (Alliance Manchester Business School 2015).

The theme of the workshop is Corporate Governance and Investment in a broad sense. We will do our best to accommodate all types of good quality papers on corporate governance and investment.

One objective of the organizers to host this workshop is the lively interaction of locally based researchers with the group to initiate joint research projects.

Submission and paper selection:

We plan to have approximately 12 papers for presentation. Each paper will be assigned a discussant, and there will be time for questions and comments from the audience. There are no parallel sessions. Submission of papers in all areas of corporate governance and investment is welcome.

Extended paper abstracts (up to 500 words) or full papers must be submitted by June 30, 2016. The authors of the accepted papers will be notified by August 1, 2016. Authors of accepted papers are expected to act as

discussants. Please submit via email to *burcin.yurtoglu@whu.edu*, stating "Submission for 17th Workshop on Corporate Governance and Investment" in the subject line of your email. There is no submission fee.

Logistics:

The organizers will cover the cost of up to two nights of local hotel accommodation for the presenters and meals. The presenters will have to cover their own travelling costs. Participation at the workshop for non-presenters is free, but places will be limited.


Conference venue and directions:

Koc University

Koç University was founded in 1993 as a non-profit private university in Istanbul, Turkey. In the twenty years since its establishment, Koç University has become one of the leading universities in Turkey, distinguished by notable contributions to the elevation of education, knowledge and service both domestically and beyond.

Corporate Governance Forum of Turkey (CGFT) at Sabanci University

Corporate Governance Forum of Turkey (CGFT) has been founded on 1st of March 2003 as a joint initiative of Turkish Industrialists' and Businessmen's Association (TUSIAD) and Sabancı University and undertook a work program as such until the end of 2004.
