International Corporate Governance Summit: Since 2008, the International Corporate Governance Summit has brought together business professionals, representatives from public and regulatory bodies, company board chairmen and members, academics, family business representatives, company shareholders, and members of the press and media.

Corporate Governance Awards: The "Corporate Governance Awards," presented annually by TKYD, aim to raise awareness of corporate governance and promote best practices.

The awards are given based on the Corporate Governance Rating Scores received by companies listed on the Borsa Istanbul Corporate Governance Index during the year.





Anatolian Seminars: Approximately 7,000 main shareholders were reached through over 100 seminars in more than 50 provinces across Anatolia.

The seminar program includes seminars hosted by Chambers of Industry and open to private sector representatives, university talks, local media meetings, and corporate governance seminars for an active civil society.

Working Groups: They plan their work on corporate governance issues in line with global and Turkish agendas, and address these issues through guidance publications, reports, feedback to regulatory bodies, webinars, and agenda meetings for the benefit of the public.

Self-Assessment Tools:







The Board Member Development Program, prepared in collaboration with the TKYD Institute and Galatasaray University's Corporate Governance, Audit, and Compliance Studies Application and Research Center (KUYDEM), consists of four parts: training, case studies, experience-sharing webinars, mentor-mentee meetings, and board meeting simulations. At the end of the nine-week program, participants receive a certificate of participation from Galatasaray University's KUYDEM.

The program, which has been running since 2021, has produced over 150 graduates, and speakers and executives maintain constant communication through Alumni meetings and a closed LinkedIn group.

The TKYD Institute, in collaboration with the International Finance Corporation (IFC) and Boğaziçi University's Lifelong Learning Center, launched the ESG Certificate Program for organizations that see ESG as the primary driver of long-term growth. The program emphasizes the contributions of ESG to business models, implementation methods, and ESG management. It provides professionals with the knowledge and skills necessary to integrate sustainability goals.
